All payments are to be made online and are in US currency (USD \$). Bank and transaction fees are at the cost of the payer.

The team fee is not reimbursable. The player fee cannot be reimbursed but can be transferred to another player.

Any Ultimate Club Team is welcome to fill out the pre-registration form to express an interest to participate at WUCC, 2018.

A bid allocation list will be compiled by the WFDF Ultimate Committee using the data collected from pre-registration. WFDF will then make firm bid offers to each Member National Federation (NF) for each division on the 21st September.

Each NF will then have the opportunity to accept or decline the bids offered and to allocate the team names they endorse to fill each bid. Not all teams pre-registered will be assured a place at the tournament. All responses from NF's should be received no later than the 30th September.

Accommodation: (First Come - First Allocated)

Travel and hotel costs will be a major part of your expenses to participate at this event. The TOC has worked hard to get special 'group' rates and packages at a variety of hotels in the area. These are limited and we encourage team administrators to investigate alternatives if they wish. Accommodation options will be on a 'first come first allocated' basis. Buses will only be provided to accredited event participants (athletes, coaches and team guests) from hotel 'hubs' to the fields and back.

TOC has arranged primary accommodation at 4 hotel hubs in the City of Mason. These hotels are around a 10 minute bus ride to the venue.

All of the tournament hotels (2 to 4 star) have given us 'group' rates and range in price from \$139 to \$209 per room night. Breakfast will be included at almost all hotels (please check when booking). Rooms include air conditioning, linens/towels changed, in room toilets/showers – some with kitchens.

Transportation:

Bus transportation will only be provided between the tournament hotels and event venues. If you stay at a hotel not listed as a tournament hotel you will need to arrange your own transportation.

Food:

Breakfast will be available at most hotels – check the offer when booking

The WUCC sports complex and stadium will have concessions and food trucks available with plenty of options for purchase.

Players may decide food options for the evening dinner yourselves. There are many options surrounding the hotels with many restaurants and markets within a few minutes' walk surrounding all of the tournament hotels.

Visas:

Once the event bid list is published and your team is registered, we encourage you make specific enquiries about obtaining a visa to enter the USA. You are responsible for obtaining the correct paperwork to visit the USA to compete at WUCC 2018.

Please note that we cannot provide specific advice on the process, but we do strongly recommend that you get started as soon as possible. The TOC can provide your team administrator with a letter confirming your team's registration at the event. To do that we generally require confirmation of the following details for all the members of your team: full name (as shown on passport), passport number, date of birth and role on team (i.e. player, coach, manager, etc).

Please make sure you leave us some time to produce this document: do not assume that we can send it back the same day!

Please note: we cannot and will not provide a formal "invitation" to attend the event and non-ability to enter the USA is not grounds for a request of a refund for a team and/or player fees. We recommend EVERY TEAM makes specific enquiries.

Travel Insurance:

All event participants (Athletes, Coaches, and Team Support) must show proof of travel insurance as part of the registration process. Non-accredited individuals will not be able to participate with the team or take part in any of the event or team functions.
